No financial support was obtained for the study. The topic has not previously been published in the AIGE. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The reference number should be indicated with square brackets in the upper right corner of the place where it is cited. 6 Recommendation: Conditional acceptance.
