For citations where the author's name is indicated in the text, a superscript number should be placed following "Pang et al". For citations where no author is indicated, a superscript number should be placed at the end of the sentence. For example, Ma [1] reported, Pan et al[2-5] believed; PCR has a high sensitivity [6,9]. No superscript numbers are used when the reference number is described in the text (e.g. The experimental method used has been described in reference [8]).
