the ablation of hepatocellular carcinoma. English style and grammar require revision. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 88 references are cited, including 37 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Springer was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National S&T Major Project of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
