2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a basic study of the ulcerative colitis. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: IBD has emerged as a major public health problem worldwide. Treatment with commonly used medications such as sulfasalazine revealed a number of side effects. Several mixtures of herbal medicines have been screened as candidates for alleviating these disorders. In this study, the authors compared the</p>	[Y]

anti-inflammatory action of sulfasalazine alone or in combination with herbal medicine for ulcerative colitis in mouse in which colitis was induced with dextran sodium sulfate. The works is useful with several experiments and a lot of results. Nevertheless, there are some points need to be improved in the manuscript. The questions raised by the reviewers should be answered; and (3) Format: There 7 figures. A total of 51 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Filipodia was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, Institutional Animal Care and Use Committee Approval Form, and ARRIVE Checklist file. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. The repeated sentences are reference lists. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Ministry of Health & Welfare through the Korea Health Industry Development Institute, and National Research Foundation of Korea (NRF) funded by the Korean government. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) The authors need to provide an editable manuscript of Word format; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved
