The author should clearly describe how they analyzed the microarray data. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 31 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Animal Care and Use Committee Approval Form. The authors need to fill out the ARRIVE guidelines with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the 66th China Postdoctoral Science Foundation; the Chinese Medicine Inheritance and Innovation "One Hundred Million" Talent Project Qihuang Scholar (Li Junxiang); and National Key R&D Program of China during the 13th Five-Year Plan Period. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
