The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade D; (2) Summary of the Peer-Review Report: This is an unusual study which goes far to fill in a serious gap in our knowledge of inflammatory bowel disease</p>	[ Y ]

in a host of third world countries/poorer countries. There are too many illustrations and tables in the article, please simplify them and express them in words if possible. Many of the information in the results section are repeated. Discussion: More focus on the study results. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 64 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) I found the authors
