association between fibrinogen-albumin ration (FAR) and the prognosis of patients with pancreatic ductal adenocarcinoma undergoing radical R0 resection. The data are interesting; and (3) Format: There are 6 tables and 2 figures. A total of 50 references are cited, including 25 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: Please provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form and Written informed consent was provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China and. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
