2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a randomized controlled trial of the educational intervention to improve colonoscopy attendance. The topic is within the scope of the WJG. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors conducted a randomized</p>	[Y]

controlled trial in a single tertiary center. They evaluated the impact of educational telephone call by a nurse on the colonoscopy appointment attendance for non-screening colonoscopies. However, there are some issues should be addressed. The exclusion criteria do not exclude patients who had prior total or subtotal colectomy. These patients may not need bowel prep and may not need sedation. Please clarify the inclusion and exclusion criteria. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 1 figure. A total of 32 references are cited, including 7 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by SNAS was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, informed consent, Clinical Trial Registration Statement, and CONSORT 2010 Statement. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Hospital del Mar. Parc de Salut Mar. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding
