Classification: Grade C; (2) Summary of the Peer-Review Report: This is a quite interesting and important study that suggests the possibility of different endotypes of PBC patients in Latin America compared to patients with other geographic background. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 2 figures; (4) References: A total of 33 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
