(2) Summary of the Peer-Review Report: Ai-Ru Hsieh et al **HBV** performed genome-wise association study of persistent-infection related single nucleotide polymorphism (SNP) in East Asian. In particular, they focused on the genetic and non-genetic factor both contributed to persistent HBV infection. This is an interesting manuscript on hepatoma cancer research. The following two comments aim to further improve the manuscript. 1. The method section could benefit from a more rigorous and detailed description. Details on Genome-wide association studies, such as coverage and QC, would benefit the manuscript. 2. The basic clinicopathological variables of the patients in this study included only age and sex, and whether the authors considered some inflammatory indicators for inclusion in the analysis Format: There are 3 figures and 5 tables. (4) References: A total of 40 references are cited, including 1 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
