The Core Tip should be reinforced to present the important findings of the analysis. The "Introduction" should be substantially shortened and the initial part of "Materials and methods" in the section "Study population and setting" should be placed in the "Introduction". According to Figure 1. the SVR achieved by patients treated with IFN was surprisingly high and reached 91.6% in the population including 37% of individuals infected with difficult-to-treat GT1a and 1b. Could you provide an explanation for so high efficacy? I suggest including in the manuscript the data on types of antiviral regimens used in patients treated with both IFN-based and IFN-free
