Please indicate the possible impact of these deficiencies on primary healthcare screening. 2.FIT screening is used in patients with lower abdominal symptoms in the cited literature[9, 10], please specify whether abdominal symptoms include upper abdominal symptoms in the report. If included, please specify the significance of FIT in patients with upper abdominal symptoms. 3. This report only compares the advantages and disadvantages with previous screening methods, without comparing new screening methods, such as multi-target fecal DNA (mt-sDNA) test (Cologuard) and plasma SEPT9 DNA methylation test (EpiproColon). 4.There are some unnecessary abbreviations, such as AA-Advanced adenoma. 5.The paper needs further proofreading. The text contains some language errors (such as singular and plural problems, lack of subject or predicate, etc.), which are sometimes difficult to understand. I suggest further polishing the language of the paper after modifying the content of the paper. (3) Format: There are 1 figures and 2 tables. (4) References: A total of 72 references are cited, including 35 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the
