For example, what do you mean by saying in the manuscripts? Therefore, is not possible to confirm? In addition tacrolimus? The paragraph 2 (or 3) is not necessary. We hypothesize that the inhibition of the calcineurin by tacrolimus could curb the production of proinflammatory cytokines, and reduce or prevent the development of the cytokine storm. Any references? A recent meta-analysis showed that liver transplant and non-liver transplant patients with COVID-19 have a similar risk of adverse outcomes (Impact of COVID-19 on liver transplant recipients-A systematic review and meta-analysis, EClinicalMedicine. 2021). Potential differences of reported studies should be discussed.
