A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The table needs to be moved to the end of the manuscript. Please modify the citation order of the references. 6 Recommendation: Conditionally accepted.
