The topic is within the scope of the World Journal of Gastroenterology. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: It's an interesting topic. As the title mentioned that the study object was EGC patients, the inclusion criteria for patients' selection should be the definition of EGC patients. This was a retrospective study, while the patients were included according to preoperative evaluated T stage (1-2), some of which might be pathologically diagnosed as T3 or T4 after surgery, which may impact the results. The surgical procedure of controlled group should be clearly stated and the stratification analysis is suggested to evaluate the oncological safety of different type of gastrectomy. The questions raised by the reviewers should be answered; (3) Format: There are 6 table and 7 figures; (4) References: A total of 29 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. 2. Language evaluation: Classification: Grade B. 3. Academic norms and rules: No academic misconduct was found in the Bing search. 4. Supplementary comments: No financial support was obtained for the study. The topic has not previously been published in the WJGO. 5. Re-Review: Not required. 6. Recommendation: Conditional acceptance
