2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a frontier of the gastric pentadecapeptide BPC 157 in cytoprotection to resolve major vessel occlusion disturbances, Pringle maneuver and Budd Chiari syndrome. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript is well written and offers a great review of the cytoprotective concept as well as the effects BPC 157 mediates within the same concept. However, the English would be simplified; and (3) Format: There are no tables and figures. (4) References: A total of 184 references are cited, including 18 references published in the last 3 years; (5) Self-cited references: There are 107 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
