The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: Reviewer 05844242 reported that the authors have done an awesome work. The reviewer warns that 6th line in the conclusion section, which reads: "If these interventions completely reverse sarcopenia remain to be studied." is not that the authors really were intended to say. Reviewer's recommendation: Accept (High priority). (3) The manuscript contains 3 tables that requires revision of format per the journal guidelines. (4) There are 120 literature references, 32 of them are published in last 3 years (which is >26%). (5) There is no self-citing. (6) References recommendations The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
