The topic is within the scope of the WJGIS. (1) Classification: Grade B (2) Summary of the Peer-Review Report: The authors have discussed a Hodgkin's lymphoma with the similar clinical feature as</p>	[Y]

adenocarcinoma and such finding is rare in literature. The questions raised by the reviewers should be answered. (3) Format: There are 0 tables and 3 figures (4) References: A total of 9 references are cited, including 1 reference published in the last 3 years (5) Self-cited references: There are 0 self-cited references. (6) References recommendations: Nil 2 Language evaluation: Classification: Grade A. There is no language editing declaration provided by the authors. 3 Academic norms and rules: The authors have not provided a signed Conflict-of-Interest Disclosure Form and Copyright License Agreement and need to be provided. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: This is an unsolicited manuscript. Financial support statement not available. The topic has not previously been published in the WJGIS. 5. Issues raised: Nil 6. Re-review required: Yes 7. Recommendation: Conditional acceptance.
