(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors reported a well-done study, which investigated an original, new concept of suturing, namely the double diabolo suture was compared to the conventional single and continuous suture technique. However, the future directions of the topic would be an in vivo, experimental animal model to prove the advantage of the method; and (3) Format: There are 3 tables and 4 figures. (4) References: A total of 27 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
