The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript is very good. This only requires little polish in language and grammar. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables; (4) References: A total of 34 references are cited; (5) Self-cited references: There are 10 self-cited references. There is no self-cited reference. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Yuan proofreading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions;(2) The title is too long, and it should be no more than 18 words; (3) PMID and DOI numbers are missing in the reference</p>	[Y]

Please revise throughout; (4) The “Article Highlights” section is missing.
