The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The present article presented by the authors, introduces citing liver cancer and as the greatest adversities faced in the late diagnosis and as consequences for the patients' lives, since most of the conclusive diagnoses for cancer it</p>	[Y]

presents in the middle or late stage. The methodology relies on the precise description of the methods used in a very complete way, even though there are few clinical studies and publications. The authors conclude the work by explaining the advantages of working with suitable biomarkers in the fight to treat diseases, making it an interesting work to read. Finally, the work presents structure, font size, the font used and its appropriate formatting. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. (4) References: A total of 89 references are cited, including 41 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
