(2) Summary of the Peer-Review Reports: The author investigated that preoperative evaluation of liver reserve function in hepatocellular carcinoma (HCC) patients with cirrhosis is critical and essential for individualizing surgical modalities for HCC patients. The comment is well-written and concise. However, there are some defects need to be modified. The authors believed that ICG-R15 is an important factor to evaluated liver function preoperatively. But from a few studies, some hold the opinion that severity of liver cirrhosis should be highlighted in clinical practice. It is suggested that this sentence be revised. The questions raised by the reviewers should be answered. (3) Format: There are no tables and figures. (4) References: A total of 4 references are cited, including 3 references published in the last 3 years; Self-cited references: There is no selfcited references. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e., those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; (5) References recommendations: 1) The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
