(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors have comprehensively described in detail the regulation of regulatory RNAs in colorectal carcinoma stem cells and the related mechanisms, including miRNA, lncRNA, and circRNA. The article is well organized, logical, and informative, with some innovation, and no previous review was conducted to summarize this topic, and the language was also embellished. The questions raised by the reviewers should be answered; (3) Format: There are 2 figures; (4) References: A total of 132 references are cited, including 68 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
