2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of the <i>Helicobacter pylori</i>, gastric microbiota and gastric cancer relationship. The topic is within the scope of the WJGO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors found an interesting topic, which tackle the complicated relationship between <i>H. pylori</i>, gastric microbiota and gastric cancer, in an effort to unroll this tangle. However, the data in Table 2 should be applied by statistical analysis; and (3) Format: There are 2 tables and 2 figures. (4) References: A total of 116 references are cited, including 19 references published in the last 3 years; (5) Self-cited references: There are 15 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
