The topic is within the scope of the WJSC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: It's a very interesting review looking at the evolving nature of the COVID-19 pandemic and rapidly changing</p>	[Y]

etiopathogenesis and manifestations. The title needs to be changed. Other mechanisms such as antiapoptotic and cytoprotective properties of EPO, potentiate mobilization of iron stores, causing interferon production, stabilizing endothelium, protecting the integrity of the pulmonary epithelial cell and attenuating pulmonary edema should also be discussed. The questions raised by the reviewers should be answered; (3) Format: There are 2 figures; (4) References: A total of 87 references are cited, including 40 references published in the last 3 years; (5) Self-cited references: There are 1 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
