Science Editor: 1 Scientific quality: The manuscript describes a basic study of the synergistic combination of chondrogenic transcription regulators sox-9 and six-1 differentiated mesenchymal stem cells into chondroprogenitors and their in vivo implantation regenerated the intervertebral disc degeneration. The topic is within the scope of the WJSC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors evaluated characteristics of genetically modified human umbilical cord-derived mesenchymal stem cells, as well as capacity of these cells to regenerate the intervertebral disc degeneration following the in vivo xenotransplantation. However, there are serious shortcomings in the way important conclusions of the in vivo part of this study are made and written. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 9 figures. (4) References: A total of 46 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer
