Science Editor: 1 Scientific quality: The manuscript describes a review of the dental stem cell-conditioned medium for tissue regeneration. The topic is within the scope of the WJSC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors found a very good review specific on preservation and storage and media for dental stem cells. The quality is good. However, some minor grammatical errors should be corrected; and (3) Format: There is 1 table and 4 figures. (4) References: A total of 141 references are cited, including 42 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
