(3) Format: There are 6 tables and 3 figures; (4) References: A total of 23 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are no self-cited references. 2 Language evaluation: Classification: Grade A. A language editing certificate was not provided. Please provide this certificate or a file explaining why it is not required. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The authors claim that review by an ethics committee and written informed consent are not required as the study was retrospective and the patients' personal information was not contained in the analyzed database. The signed Conflict-of-Interest Disclosure Form and Copyright License Agreement are not provided. Please, provide these files. No academic misconduct was found by the Google search. 4 Supplementary comments: No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The journal does not have on-line supplementary materials. Please renumber the tables to include supplementary tables. (2) Supplementary Table 2 refers to Figure 1 rather than Figure 2 as described in its title. (3) The authors did not provide original pictures. Please provide the original figure files. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can



	be reprocessed by the editor; (4) The "Article Highlights" section is	
	missing. Please add the "Article Highlights" section at the end of	
	the main text (and directly before the References); 6 Re-Review:
