Science Editor: 1 Scientific quality: The manuscript describes an observational study of the COVID-19 in the endoscopy unit. The topic is within the scope of the WJG. (1) Classification: Grade C, Grade B, Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors present the results of an observational study aimed to assess the risk of COVID19 contagion in the endoscopy unit under current clinical practice recomendations. It is interesting and well-written. However, the questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. (4) References: A total of 18 references are cited, including 18 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
