clinical and interest, and the topic is within the scope of the World Journal of Hepatology. (1) Classification: Grade C (2) Summary of the Peer-Review Report: There are a lot of methodological details that need clarification. 1. It is unclear when the data was collected (5-10 years ago?) or now some years after transplantation? 2. What was the time interval between the surgery and the interviewing the patients? 3. How long does it take to manage biliary complications and how it impacted the organ and/or recipient survival? How it influenced the readmission rate, duration of hospital stay, etc. How many patients needed reoperations due to biliary strictures? 4. If the data was collected 10 years ago, so why it was not published anywhere? 5. How the survey was carried out and the data analyzed retrospectively? Furthermore, the data presented in the graphs and tables overlaps, presentation of clinical data needs improvement and inclusion of analysis of organ/recipient survival in groups with and without biliary complications. The questions raised by the reviewer should be answered. (3) Format: There are 5 tables and 2 figures; (4) References: A total of 54 references are cited, including 23 references published in the last 3 years. (5) Self-cited references: There is no self-cited references. (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
