	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a review of the gastrointestinal and hepatic side effects of potential treatment for COVID-19 and vaccination in patients with chronic liver diseases. The topic is within the scope of the WJH. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The submitted article is valuable. The present study was well organized or reviewed adverse GI symptoms or hepatic injury related to COVID-19 treatment drugs and vaccines. However, there are still some minor issues that need to be corrected. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 138 references are cited, including 79 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
