is within the scope of the WJH. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors reviewed the published information about liver injury during SARS-CoV-2 infection with a special attention to possible mechanisms of liver damage and abnormalities in liver function tests allowing for evaluation of liver disease severity. This is a very interesting review subject. However, the questions raised by the reviewer should be answered; and (3) Format: There is 1 figure. (4) References: A total of 64 references are cited, including 62 references published in the last 3 years; (5) Self-cited references: There are no self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
