However, this review needs major revision. c) Format: 4 figures and 4 tables. d) References: A total of 46 references are cited, including 27 references published in the last 3 years. e) Self-cited references: No Self-cited references. (2) Language evaluation: Classification: Grade B. (3) Academic norms and rules: the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement is missing. The Institutional Review Board Approval Form and sWritten informed consent was waived. No academic misconduct was found by the Bing search. (4) Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJH. (5) Issues raised: (6) Re-Review: Not required. (7) Recommendation. minor revision.
