Science Editor: 1 Scientific quality: The manuscript describes a Retrospective Study about Oral vancomycin in children with autoimmune liver disease. A single center experience. The topic is within the scope of the WJH. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: Although, the study sample was only 75 candidates, yet the outcome was statistically significant (biochemical improvement of AST, ALT and GGT in around 11% with p=.05). The use of vancomycin in such cases (Autoimmune liver disease in kids) has been studied over the last few years, however, no RCTs have yet supported the full use of OVT. The hypothesis of such observational study is reasonable and in the near future, more studies should be done to help clinicians in treating such cases. Methodology and statistical analysis were adequate and clearly explained in the right sections. Results, discussion and conclusion were all reflective of the study findings and well supported with figures, tables and references. (3) Format: There are 4 tables and 2 figures; (4) References: A total of 28 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There are 0 self-cited references. (6)References recommendations: There references were recommendations by reviewers. 2 Language Classification: Grade A. A language editing certificate was provided by a proficient English user, Lorenzo D'Antiga. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the
