The authors are native English speakers. 3 Academic norms and rules: No academic misconduct was found in the Bing search. No academic misconduct was found in the CrossCheck detection. 4 Supplementary comments: No financial support was obtained for the study. The topic has not previously been published in the WJH. 5 Issues raised: The “Author Contributions” section is missing.
