The primary responsibilities of scientific editors include carefully checking the entire manuscript and all accompanying materials for:

- errors in spelling, grammar, punctuation and wording
- suitability of tables, figures, figure data and legends
- accurate and appropriate presentation of symbols (e.g. +, -, ×, ÷, %, \*) in tables and figures
- complete and comprehensive revision of the manuscript according to the reviewers' comments

| 14 | The 'INTRODUCTION' section clearly describes the relevant background information for the study. Only the most relevant and current (within the past 5 years) literature is cited, with the exception of rare instances of seminal literature citations. First-person pronouns (e.g. 'I', 'we') are used appropriately to clearly indicate the work performed by the author(s). | 16 | The 'RESULTS' section concisely describes the observatory and experimental results. Representative data and data that have scientific significance are emphasized. | 23 | The 'REFERENCES' section lists the references in the Vancouver style. This style uses Arabic numeric in-text citations based on the order of the first appearance of a source in the text. For citations where no author is indicated, a superscript number should be placed at the end of the sentence. For example, Ma <sup>[1]</sup> reported ....., Pan et al <sup>[2-5]</sup> believed ....., PCR has a high sensitivity <sup>[6,9]</sup> . No superscript numbers are used when the reference number is described in the text (e.g. The experimental method used has been described in reference [8]).
