For citations where the author's name is indicated in the text, a superscript number should be placed following the name (<i>i.e.</i> , "Pang et al ¹ "). For citations where no author is indicated, a superscript number should be placed at the end of the sentence. Respective examples are: "Ma ^[1] reported", "Pan et al ^[2-5] indicated", "PCR has a high sensitivity ^[6,9] ."
