junction adenocarcinoma treatment. However, the questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. (4) References: A total of 26 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the [editorialoffice@wjgnet.com](mailto:editorialoffice@wjgnet.com).
