(1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The article is a review study and should be mentioned in the title. The abstract is not clear and the author should give more details about his subject. There is lack in the conclusion part. The tables should be restructured and optimized for readers; and (3) Format: There are 4 tables. (4) References: A total of 40 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
