The questions raised by the reviewers should be answered; (3) Format: There are 6 tables and 2 figures; (4) References: A total of 27 references are cited; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. Authors declare that Institutional Review Board was not applicable. This study does not involve human experiments or invasive procedures. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6
