Science Editor: 1 Scientific quality: The manuscript describes a review of the advances in Pediatric NAFLD. The topic is within the scope of the WJCP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The review covers much more than the genetic variants in NAFLD, which should be mentioned more in detail in the abstract. The authors should provide some tables to summarize the main findings from the literature. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 1 figure; (4) References: A total of 154 references are cited, including 82 references published in the last 3 years; (5) Self-cited references: There are 13 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
