The topic is within the scope of the WJP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: There are problems in the abstract and introduction that need to be further revised, and the references are too old. The questions raised by the reviewers should be answered; (3) Format:</p>	[Y]

There are 1 table and 5 figures; (4) References: A total of 91 references are cited, including 7 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference.

2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search.

4 Supplementary comments: This is an invited manuscript. The study was supported by Neursearch Center. The topic has not previously been published in the WJP. 5 Issues raised: (1) I found no "Core tip" section. Please add; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the Figures cited in the original manuscript in the form of PPT. All text can be edited, including A, B, arrows, etc. With respect to the reference to the Figure, determine if it is the original Figure, if not, please provide the source of the picture and the proof that the Figure has been authorized by the previous publisher or copyright owner to allow it to be redistributed; (4) I found the authors did not add the PMID and DOI in the reference list. Please add the number directly; (5) Tables are not allowed to be inserted in the manuscript and should be moved to the end of the manuscript.
