The topic is within the scope of the WJP. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: This paper</p>	[Y]

investigates the decline of mental health among people in England during the nationwide lockdown period implemented by the UK government in facing the Covid-19 pandemic. The findings in this research are very interesting and informative. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 2 figures; (4) References: A total of 30 references are cited, including 22 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (6) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
