Science Editor: Specific Comments To Authors: This invited manuscript reviewed and summarized autologous transplantation in eyelid reconstruction, which is an important and significant topic for clinical work. The structure and content of the manuscript are complete, and the references are complete and new. This minireview can be a good guide to various surgical methods for clinical eyelid reconstruction, which is very helpful for eyelid reconstruction after tumor and trauma.
