There is still a final detail that could be corrected. When the THERAP clinical trial is mentioned throughout the manuscript, its name is always reported in lowercase (i.e. "therap"), but there are two exceptions (outlined in the image below) where this name is spelled as "TheraP". For sake of consistency, also these two occurrences of this term could be spelled in lower case as the others.)
