**HAVE AGREED** to the following terms and conditions regarding the research project mentioned above and described in the proposed original Research document (Appendix 1), which forms an integral part of this grant agreement.

## 1. Scope of Work

EULAR grants to UNIVERSITY ("Beneficiary") and Beneficiary accepts support for research investigations under the direction of Dr. Ana M Valdes at The University off Nottingham as described in Appendix 1 (Research).

## 2. Grant Payment

In consideration of Beneficiary's exerting its good faith efforts to carry out the Research EULAR will pay Beneficiary a total grant amount of maximum:

EUR 144,757

EULAR will pay the total amount in yearly periods according to the budget provided in the Research proposal (Appendix 1). The yearly payment schedule is as follows:

- 50% of annual budget as pre-financing at the beginning of the year

- Remainder of the annual budget at the end of the year upon receipt of a detailed expense statement as well as a scientific progress report

Payments shall be transferred to an account to be named by Beneficiary.

### **3. Period of Performance**

Research under this Agreement will be performed during the period of 36 months, starting on 4<sup>th</sup> February 2013 (Start Date).

### **4. Principal Investigator**

Beneficiary's Principal Investigator shall be Dr. Ana M Valdes who shall be responsible for the direction and conduct of the Research and the diligent management of the funding provided hereunder.

### **5. Reports**

The Principal Investigator shall report to EULAR with respect to the progress of the Research at least once per year. Within six months after the expiration of this Agreement, the Principal Investigator shall submit a summary report to EULAR as well as at least one publication related to the Research (cf. article 6). EULAR shall keep all such reports and all information obtained from Beneficiary confidential and only use them in accordance with this Agreement.

### **6. Publications**

Beneficiary will strive to publish the results and discoveries emanating from the Research and acknowledge EULAR in any such publication for the funding received hereunder.

### **7. Intellectual Property**

Research tools such as standardised questionnaires, etc. developed as part of the Research shall be freely available to the public without charge.

### **8. Governing Law**

This Agreement shall be governed by the laws of Switzerland, without reference to its conflict of laws principles; the exclusive place of jurisdiction being Zurich (Switzerland).

### **9. No Oral Modification**

No change, modification, extension, termination, or waiver of this Agreement, or any of the provisions herein contained, shall be valid unless made in writing and signed by duly authorized representatives of the parties hereto.

### **10. Effective Date, Term and Termination**

This Agreement is effective (Effective Date) commencing on the date that it is executed by all the parties. In the event that all the parties do not execute this Agreement on the same date,

then this Agreement is effective commencing on the date that the last party executes this Agreement.

This Agreement shall expire 36 months after Start Date unless extended or sooner terminated in accordance with the provisions of this section.

In the event Beneficiary's Principal Investigator is unavailable or unable to continue direction of the Research for a period in excess of ninety (90) days, Beneficiary shall notify EULAR and may nominate a replacement; if Beneficiary does not nominate a replacement or if that replacement is unsatisfactory to EULAR, EULAR may terminate this Agreement upon thirty (30) days written notice.

If EULAR fails to meet any of its obligations under this Agreement and shall fail to remedy these failures within sixty (60) days after receipt of written notice thereof, Beneficiary shall have the option of terminating this Agreement upon written notice thereof. In the event Beneficiary fails to meet its obligations under this Agreement and shall fail to remedy these failures within sixty (60) days after receipt of written notice thereof, EULAR shall have the option of terminating this Agreement upon written notice.

Upon termination of this Agreement, EULAR shall reimburse Beneficiary for all reasonable expenses or irrevocable commitments incurred as of the date of notice of termination but not to exceed the total amount committed under this Agreement.

Termination or expiration of this Agreement for reasons other than an unremedied failure to meet the material obligations under this Agreement shall not affect the rights and obligations of the parties accrued prior to termination.


