The manuscript should be reviewed for spelling mistakes. 2.It is said that there is an English certificate, but a form that does not belong to an institution has been uploaded. Details should be shared about whether there is a person at a level that can issue a certificate about the person who signed this letter or this certificate should be obtained from an institution. 3. The reference units in the laboratory values section are not written in the article, they should be added. 4.The names of the hospitals to which the patient applied were given before, but I think that the hospital name should not be given ethically, as it will be perceived as disparaging these hospitals. The other hospital names should be removed from the article 5. It is said that the patient was given hormone therapy, but which hormone was not mentioned. Details about hormone therapy should be given. 6. In the literature, drug-induced EF is mentioned. Is there a factor that they think may be involved in the etiology of this patient? for example, the drugs he used for diabetes. this description can be added to the manuscript. Kind Regards
