SPECIFIC COMMENTS TO AUTHORS

This case is interesting and well illustrated, some minor points could be considered: 1. Some terms should be improved (e.g. “correctly stress” (P3, L51,61; P13,L282) (stress?); “this article reports” (P3,L59) (this report?) 2. On the L48 the time of last clinical evaluation should be explained. 3. The text and some figures could be shortened if space is critical. 4. The line “to our knowledge, which has not been reported previously” (P4,L80-81) is unnecessary and could be deleted.
