The author should not define the case in the introduction section. The author should be able to explain in more detail the patient's clinical symptoms, diagnostic procedures, and therapy performed on this patient. The second case was confusing for diagnosis, mainly because there was an enlarged lymph node in the pelvic area. In the discussion section, it is better to add a discussion regarding PPL's specific treatment (chemotherapy and or radiotherapy) and prognosis survival rate. Authors should be able to consult with native speakers to improve English grammar. The author should explain the limitations of this case report.

Please provide a rationale in the introduction why the Two cases of prostate lymphoma is significant for publication. The authors mentioned (Both kidneys and ureters were dilated with fluid). Please consider terms like hydronephrosis or hydroureteronephrosis. Does this statement (the patient underwent prostate puncture and electrosurgery of the bladder mass for pathological biopsy) means transrectal core prostate biopsy and transurethral resection biopsy? Please revise the conclusion to avoid run-on sentences.
