COMMENTS TO AUTHORS

This paper reports the case of serious complications in a variety of organs after intravesical BCG instillation. The manuscript is basically well written and the case I worth being informed. However, there are several point to be revised. 1. First of all, add page numbers in the manuscript. 2. "afectation" (it should be "affectation") in the title seems to be inadequate. Through the manuscript, I strongly recommend to ask a native English speaker to check English of the manuscript before submission. Minor points: Page 2, line 13. "afectation" seems to be inadequate as in the title. Page 2, line 15. "M. Bovis" reads "Mycobacterium bovis". Page 3, line 4. Add "to" after "due". Page 3, line 6. Remove "involvement". Page 3, line 3 from the bottom. "(figure 1-2)" reads "(Figures 1, 2)". Page 4, line 3. Is "pncAC169G (H57D)" a name of a BCG strain? Page 4, line 14. "precociously" seems to be inadequate. Page 5, line 6. "M. Bovis" reads "M. bovis". Page 5, line 8. "The meaning of "the patient was prolonged" is not clear. Page 5, line 10-. The paragraph started with "In conclusion" should be revised to make the meaning clearer.
